
# Investment strategy


The Fund's primary investment objective is to achieve capital appreciation by investing in a diversified, yet concentrated portfolio of publicly listed life sciences companies (including biopharmaceutical-, specialist pharmaceutical-, medical device-, drug delivery-, vaccine- and diagnostic companies). The majority of the Fund's portfolio will consist of European companies listed on one of the (main) European stock exchanges, with a market capitalization of below € 2.5 billion at the time of investment.

# Manager's comments


The Fund's investment strategy to buy minority interests in publicly listed companies, no longer falls within the active and private investment strategy that all other funds managed within the EQT Group, adhere to. The Fund therefore has put to vote at the Annual General Meeting of Shareholders (AGM) that was held on 31 May 2024, the resolution to dissolve the Company. This resolution has been approved and as a consequence, the Fund has initiated the liquidation process.
